NOTE

Under Internal Revenue Regulations, tax-exempt charitable organizations generally must provide requesters with COPIES of:

- Its approved exemption applications, all required attachments and any related correspondence with the IRS, and
- Its three most recent annual information returns (Form 990), including all schedules and attachments (but not the names and addresses of contributors).

In-person requests: *A member of the public may request to inspect the documents at any principal office of the organization. The entity must provide the information requested that same day. However, if the request places an “unreasonable burden” on the organization, the staff must provide copies of the requested information no later than the next business day after the unusual circumstances cease to exist (limited to a maximum of five business days after the request).*

Written requests: *Written requests made by fax, mail, email, or overnight service, which include the requester’s address, must be honored within 30 days of receipt.*

Website alternative: *Instead of providing copies, an organization may make the documents available on either its own or another organization's website. If it uses this option, it has to: (1) provide an exact replica of the document as was filed with the IRS; (2) advise requesters how to access the forms on the web; (3) the site should charge no access fee and require no special software or hardware to download. Organizations that post this information on the Internet still must honor in-person requests to view the applicable documents.*

Permissible charges: *Tax-exempt organizations may charge a reasonable copying fee, up to \$1 for the first page and 15 cents for each additional page, plus actual postage costs.*

Penalties: *An organization that fails to comply with the new disclosure requirements may be subject to the following penalties:*

- Annual Information Return – Form 990 - \$20 per day for as long as the failure continues, up to a maximum of \$10,000 for each failure to provide an annual return.
- Exemption Application - \$20 per day with no maximum.
- An organization that willfully fails to comply with these public inspection rules can be subject to an additional \$5,000 penalty.

Private foundation exempt: *The new disclosure rules don't yet apply to private foundations. They must still make a copy of their annual return available for public inspection at their principal office for a period of 180 days after publishing a notice of availability.*

Between the International Mountain Bicycling Association and the International Mountain Bicycling Association-Colorado

This Plan and Agreement of Merger (this "Agreement") dated, February 6, 2016, by and between International Mountain Bicycling Association, a California nonprofit public benefit corporation, qualified to do business in Colorado as International Mountain Bicycling Association ("IMBA-California", FEIN 77-0204066), and International Mountain Bicycling Association - Colorado, a Colorado nonprofit public benefit corporation ("IMBA-Colorado", FEIN 47-1254119).

Recitals

- A. IMBA-California is a nonprofit public benefit corporation duly organized and existing under the laws of the State of California.
- B. IMBA-Colorado is a nonprofit corporation duly organized and existing under the laws of the State of Colorado.
- C. IMBA-California and IMBA-Colorado desire to adopt this Agreement for the merger of IMBA-California with and into IMBA-Colorado (the "Merger"), pursuant to the applicable laws of the State of California and the State of Colorado.
- D. The board of directors of both IMBA-California and IMBA-Colorado approve the Merger in that certain Joint Consent of the Board of Directors of IMBA-California and IMBA-Colorado, to be executed on a date no sooner than the date of IRS approval and notification of exempt status (application pending as of January 4, 2016) and no later than December 31, 2016.
- E. Both IMBA-California and IMBA-Colorado have no members or other non-director individuals entitled to vote on the Merger.
- F. Pursuant to Section 7-131-102(4) of the Colorado Revised Nonprofit Corporation Act (the "Act") and Section 6011 of the California Corporations Code, the Merger shall be approved and adopted by a majority of directors of IMBA-California and IMBA-Colorado elected and in office at the time this Agreement is considered.

Agreement

NOW, THEREFORE, in consideration of the mutual benefits to be derived from the Merger, the parties agree as follows:

ARTICLE I

Effects of the Merger

At the Effective Time (as defined below) of the Merger, IMBA-California shall be merged with and into IMBA-Colorado on the terms and conditions herein set forth, as permitted by and in accordance with the Act. Thereupon, the separate existence of IMBA-California shall cease, and IMBA-Colorado, as the surviving corporation, shall continue to exist under and be governed by the Act.

At the Effective Time, all of the property of IMBA-California and IMBA-Colorado, real, personal and mixed, and all of the rights, privileges, immunities, powers, purposes and franchises of a public or private nature, all patents, licenses, trademarks, registrations and causes of action, all debts due on whatever account, and each and every action, shall be deemed to be transferred to, vest in or devolve upon IMBA-Colorado, without act or deed; and any title to any real estate or any interest therein, whether vested by deed or otherwise, in either of IMBA-California or IMBA-Colorado shall not revert or be impaired in any way by reason of the Merger. IMBA-Colorado shall thenceforth assume and be liable for all of the debts, liabilities, obligations, duties and penalties of each of IMBA-California and IMBA-Colorado, and all such debts, liabilities, obligations, duties and penalties shall thereafter attach to IMBA-Colorado and may be enforced against IMBA-Colorado as if such debts, liabilities, obligations, duties and penalties had been incurred or contracted by it. No liability or obligation due at the Effective Time, or then to become due, or any claim or demand for any cause then existing against either of IMBA-California or IMBA-Colorado, or any officer or director of either of them shall be released or impaired by the Merger, and all rights of creditors and all liens upon the property of either of IMBA-California or IMBA-Colorado shall be preserved unimpaired.

Articles of Incorporation and Bylaws
